**DIRECT PURCHASER PLAINTIFFS’ MOTION FOR ATTORNEYS’ FEES,
LITIGATION EXPENSES, AND SERVICE AWARDS**

Pursuant to paragraph 26 of the Court’s Order Granting Direct Purchaser Plaintiffs’ Motion for Preliminary Approval of Class Action Settlements with Ferrellgas and AmeriGas, court-appointed Settlement Class Counsel Berger Montague PC, Cohen Milstein Sellers & Toll, PLLC, Susman Godfrey L.L.P., and Shaffer Lombardo Shurin, P.C.
